1. An Election is to be held for three Parish Councillors for Nocton Parish Council.
2. Forms of nomination for the Parish Election may be obtained at North Kesteven District Council, Council Offices, Kesteven Street, Sleaford, NG34 7EF from the Returning Officer who will, at the request of an elector for any electoral area prepare a nomination paper for signature. Given the restrictions associated with Covid-19, any request for nomination papers should be made via email at [elections@n-kesteven.gov.uk](mailto:elections@n-kesteven.gov.uk) or telephone (01529) 308352.
3. Nomination papers must be delivered by hand to the Returning Officer, North Kesteven District Council Offices, Sleaford NG34 7EF on any working day from the date of publication of this notice, **Monday to Friday between 10am – 4pm** but no later than **4pm on Friday 23rd July 2021**. Given the restrictions associated with Covid-19, **it is strongly advised that candidates make an appointment** with the Returning Officer in order that their nomination can be handed in by this deadline. Any request for an appointment should be made via email at [elections@n-kesteven.gov.uk](mailto:elections@n-kesteven.gov.uk) or telephone (01529) 308352.
4. If any election is contested the poll will take place on **Thursday, 19th August 2021**.
5. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Tuesday 3rd August 2021**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
6. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at North Kesteven District Council, Council Offices, Kesteven Street, Sleaford, NG34 7EF by **5pm on Wednesday, 4th August 2021**.
7. New applications to vote by proxy at this election must reach the Electoral Registration Officer at North Kesteven District Council, Council Offices, Kesteven Street, Sleaford, NG34 7EF by **5pm on Wednesday, 11th August 2021**.
8. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at North Kesteven District Council, Council Offices, Kesteven Street, Sleaford, NG34 7EF by **5pm on Thursday, 19th August 2021**. The physical incapacity must have occurred after **5pm on Wednesday, 11th August 2021**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5pm on Wednesday, 11th August 2021**.
